## Storage and handling

The active ingredients in our inoculants are living organisms and require specific storage conditions to ensure viability and product performance.

To maintain product viability in packaging:

- Store all inoculants and treated seed under cool conditions, away from sunlight and direct heat sources.
- Minimize temperature fluctuations and avoid freeze/thaw cycles.
- Use before the expiration date. The expiration date is valid for unopened containers stored according to the conditions indicated.

### Storage of peat-based inoculants

- Store in cool, dry conditions.
- May be frozen; if peat bags freeze, keep frozen until shortly before use.

### Storage of granular inoculants

- Store in cool, dry conditions.
- Granular products have a 2-pallet stacking height.
- May be frozen; if granular inoculants freeze, keep frozen until shortly before use.
- If granular inoculant freezes, lumps may form, please use a screen when filling your tank. When using 18 kg bags, drop bags on each side prior to opening.

### Storage of liquid inoculants

- Avoid freezing.
- Freezing liquid inoculants may result in damaged bladders, which can lead to contaminated product or problems with application.

### Storage of JumpStart wettable powder

- Store in cool, dry conditions, less than 20°C (68°F).
- May be frozen; if JumpStart does freeze, keep frozen until shortly before use.

### Storage of seed treated with JumpStart wettable powder

- Store in cool, dry conditions.
- May be stored in unheated storage.
- May be frozen; if frozen, keep frozen until shortly before use.

### Storage of QuickRoots wettable powder

- Store unopened containers of QuickRoots in a dry cool place, less than 20°C (68°F), away from sunlight and heat sources.
- Unopened packaged product will remain viable up to two years when stored properly.
